2021 Edition - Construction & Professional Services Manual - Revision 0

I. Purpose of this Notice:

The purpose of this notice is to announce the issuance of Revision 0 of the 2021 Edition of the Construction and Professional Services Manual (CPSM) and to summarize the changes which have been incorporated since Revision 0 of the 2020 Edition was issued on 07-01-20.

This and other recent editions of the CPSM are available on <u>DEB's website</u> for viewing or download.

II. Summary of Changes
