# 2022 Edition - Construction & Professional Services Manual - Revision 1

# I. Purpose of this Notice:

The purpose of this notice is to announce the issuance of Revision 1 of the 2022 Edition of the Construction and Professional Services Manual (CPSM) and to summarize the changes which have been incorporated since Revision 0 of the 2022 Edition was issued on 08-01-22.

This and other recent editions of the CPSM are available on <u>DEB's website</u> for viewing or download.

# II. Summary of Changes

The changes incorporated into Revision 1 of the 2022 Edition of the CPSM are as follows:

# A. Chapter 1 - Introduction

<u>General</u>

Added *Code of Virginia* reference to Section 1.0 for Shielded Outdoor Light Fixtures.

Modified Section 4.19.3.3.4 to add grandstands, address egress lighting, and clarify other requirements.

Modified Section 4.20.6 regarding submission to DEB of documentation for Changes to the Work prior to Building Official inspections.

Modified Section 5.3.3 to add Form CO-13.1c "Certificate of Partial or Substantial Completion by Agency Project Manager" to the list of forms required to be included in the Project Manual.

## Design Initiations / Pre-Design Conference

Modified Section 5.5 to add Energy/VEES and Mass Notification Systems to the list of topics that may be included in the pre-design conference agenda.

#### <u>Schematic Drawings – Title Sheet</u>

Modified Section 5.6.2.4.1 to add item 18 for Mass Notification Systems.

## <u>Preliminary Drawings – Title Sheet</u>

Modified Section 5.7.2.9.1 to add item 26 for Mass Notification Systems.

#### Working Drawings - Title Sheet

Modified Section 5.8.6.2 to add item 30 for Mass Notification Systems.

## Working Drawings - Electrical Drawings

Modified Section 5.8.6.12 to add item 15 for Mass Notification Systems.

#### **Reviews and Approvals**

Modified Section 5.12.2 for submission to DEB of Permit Documents and changes to Permit Documents.

#### Value Engineering (VE)

Modified Section 5.14 to clarify that a VE study is required for Capital Projects with a project construction cost greater than \$5,000,000.

## Interim Building Official Inspections

Modified Section 7.6.17.6 to require submission to DEB with Changes to the Work a minimum of five (5) days prior to all required Building Official inspections.

#### **Substantial Completion Inspections**

Modified Section 7.6.17.7 to require Form CO-13.1c "Certificate of Partial or Substantial Completion by Agency Project Manager" to be submitted to DEB by the Owner indicating all Changes to the Work affecting building code compliance or accessibility have been submitted to DEB.

Beneficial Occupancy – New Buildings, Additions & Change of Use Renovations Modified Section 7.6.17.8 to require Form CO-13.1c "Certificate of Partial or Substantial Completion by Agency Project Manager".

## H. Chapter 8 – Capital Outlay Planning and Project Approval

## **Building Occupancy**

Modified Section 8.7.8 to require Form CO-13.1c "Certificate of Partial or Substantial Completion by Agency Project Manager" to be submitted for building occupancy.

Added item 25 to Section D.1 for Mass Notification Systems.

## Preliminary Basis of Design Information

Added item c) to Electrical requirements in Section D.21 for Mass Notification Systems.
