2025 Edition - Construction & Professional Services Manual - Revision 0

I. <u>Purpose of this Notice</u>:

The purpose of this notice is to announce the issuance of Revision 0 of the 2025 Edition of the Construction and Professional Services Manual (CPSM) and to summarize the changes which have been incorporated since Revision 1 of the 2024 Edition was issued on 10-10-2025.

This and other recent editions of the CPSM are available on <u>DEB's website</u> for viewing or download.

Recently revised capital outlay forms, available on the DEB Forms Center, are listed.

II. Summary of Changes

The changes incorporated into Revision 0 of the 2025 Edition of the CPSM are as follows:

A. Chapter 1 – Introduction

General

Revised Section 1.0 for 2024 CPSM, Rev. 1.

Capital Outlay Projects

Revised Section 1.3.1 to remove exclusion of CO-6 forms from Construction Management at Risk projects.

Revised Figure 1.3.1 *General Guide to Key Form Submittals* to add submission of CO-6 forms for CM projects, to revise Note N regarding maximum job order amounts, and to add Norfolk State University to list of Tier 2 agencies.

B. Chapter 4 – Code and Technical Requirements for All Buildings on State Property

Design Rain Loads

Modified Section 4.1.2.18 to clarify ASCE7-22 shall be used for structural calculations.

Fire walls

Deleted clarification pertaining to fire walls in Section 4.1.2.19.

Enhanced Classroom Acoustics

Added Section 4.1.2.19 for clarification of scoping for enhanced classroom acoustics.

Plumbing Vent Unprotected Roof Extension

Modified Section 4.1.2.28 to change the word "greater" to "greatest".

<u>Labeling of water distribution pipes in bundles</u>

Added Section 4.1.2.32 for clarification regarding pipe identification.

Domestic Water Circulation Systems

Added Section 4.1.2.33 for clarification to circulation loop temperature setpoint for deactivation of the pump.

Guards on Roofs

Added Section 4.1.2.34 for clarification regarding attachment of guards on roofs to building structure.

Safety Standard for Refrigeration Systems

Added Section 4.1.2.35 for applicable edition of ASHRAE 15 referenced by the Virginia Mechanical Code.

Intermodal Shipping Containers

Added Section 4.1.2.36 for clarification that CPSM Appendix A applies to intermodal shipping containers.

Accessibility Standards for State-owned Facilities

Added clarification that ICC A117.1-2017 Section 1001.2.1 further clarifies scope of recreational facilities required to be accessible.

Added clarification that 2010 ASAD remains accessibility standard for projects with permits issued under 2018 VCC or 2018 VEBC.

Modifications

Added paragraph to Section 4.2.1 to clarify when renovations of existing buildings shall meet accessibility requirements for new buildings and facilities.

Dwelling Units and Sleeping Units

Deleted Section 4.2.2.20.

Private Offices

Added Section 4.2.3.4 for clarification that exceptions to accessibility requirements for rooms associated with private offices do not apply.

Federal Investment tax Credits for Green Energy Properties

Modified Section 4.23 for qualified energy properties and submission requirements.

Preliminary Submittal Requirements

Modified Sections 5.7.2 and 5.7.2.2 to add submittal of a copy of the approved permit issued by DCR for projects located in a floodplain.

Working Drawings Submittal Requirements

Deleted item 5 from Section 5.8.5 pertaining to application documents for Federal Investment Tax Credits.

Architectural Drawings

Added item 9 to Section 5.8.6.5 requiring the working drawings to provide specific information for accurately marking walls that require protected openings or penetrations.

Control Systems

Modified item 1 in Section 5.8.6.13 for identification of sequences to be performed using equipment manufacturer's packaged controls.

Advertising

Modified Section 5.9.5 to remove requirement to coordinate bid receipt dates through DEB.

Value Engineering

Modified Section 5.14 to provide options for electronic submittals and communication.

Modified item 1 in Section 6.1.3.2 for VEES Section 401.2 compliance paths.
